# **REQUIRED MATERIALS**

Students will access digital textbook materials for key course content.

Students will be provided with specialized gear and equipment necessary to fulfill the requirements of the course, and are expected to carefully follow instructions regarding the care and usage of all gear/equipment.

#### GRADING SYSTEM

Students will be assessed using a total points system. Grading will include classwork/homework, projects, quizzes, practical tests and written tests.

The NC Office of the State Fire Marshall governs all testing at the end of each chapter. A written test and two practical tests will be given at the end of each chapter. Students are required to pass practical and written exams with a minimum score of 70% to satisfy OSFM standards. OSFM allows all students the opportunity to retest once in both the practical and written exams. All retests need to be taken within 30 days to be counted for state certification. Students unable to achieve that passing score will receive a high school grade but will not achieve state certification in that subject.

The NC State mandatory final exam is worth 20% of the final grade. NO STUDENT CAN BE EXEMPT FROM THIS EXAM.

## **CLASSROOM EXPECTATIONS**

- 1. All school rules apply; please refer to the school handbook
